#### What is a serve of fruit?

1 medium apple, banana, orange or pear

2 small apricots, kiwi fruits or plums

1 cup diced or canned fruit (no added sugar)

Or only occasionally:

125ml (½ cup) fruit juice (no added sugar)

30g dried fruit (for example, 4 dried apricot halves, 1½ tablespoons of sultanas)

# What is juice from concentrate?

Depending on the technique, the juice is either heated by steam so the water in juice evaporates, or 'ultra-filtrated', and then concentrated using reverse osmosis. Reverse osmosis is a purification process that uses a partially permeable membrane/filter to remove large unwanted particles by applying an pressure.

To bring the concentrate back to its previous form, water is added to reconstitute the product to an agreed standard (brix). Finally, the juice is pasteurised before packaging.
